

# FILMMAKER FESTIVAL 2024

## COMPETITION ANNOUNCEMENT

The 2024 edition of Filmmaker will take place in Milan from November 16th to November 24th

### The organizers

The Festival is organized by Filmmaker associazione per la promozione del Prodotto Audiovisivo d'Innovazione, having its registered office in via Giuseppina Lazzaroni 8, Milan (Italy), in collaboration with public institutions, cultural associations and private partners that support the project and its organization.

### The aim

The Festival promotes independent and avant-garde cinema, paying special attention to documentary, experimental and young Italian cinema.

### Festival sections

The Festival is divided into five sections, two are competitive: The International Competition, focused on documentaries, experimental films, non-fiction films, film essay, animated films; Prospettive Competition, dedicated to young Italian cinema; Out of Competition section, Filmmaker Expanded, Homages and Special Programs.

## ELEGIBILITY

### International Competition

Unpublished Italian and International films will be considered eligible for submission, as well as films screened after July 16, 2023. Submission is allowed for works of any length, format (film, video, HD or SD digital) and genre (documentary, experimental cinema, non-fiction films, film essay, animated films).

National premiere is required for the admission to the selection. The world premiere is considered a preferential factor.

Films already distributed on the web, those already presented through SVOD / TVOD / AVOD platforms geolocated in Italy.

### Prospettive Competition

Unpublished Italian and International films by Italian filmmakers (Italians or living in Italy) born after November 16, 1988 will be considered eligible for submission, if the first public screening took place after July 16, 2023. Works of any length, format (film, video, HD or SD digital) and genre are eligible for submission.

The national premiere is required for the admission to the selection. The world premiere is considered a preferential factor.

### **Out of Competition**

Unpublished Italian and International films will be considered eligible for submission, as well as films screened after July 16, 2023. Films screened in Milan before the dates of the Festival are excluded from this section.

### **HOW TO APPLY**

The submission fee is 10 € and is charged for each film submitted to cover administrative expenses. Only submissions with a valid proof of payment will be accepted.

The form must be filled by October 11, 2024. During the submission, it will be asked to attach a proof of payment. In case of non-selection, the 10 € fee will not be refunded.

### **Screener**

Films must be submitted by providing a private, downloadable copy of the film (Vimeo or YouTube) as specified in the entry form. Copies of films and information materials sent by mail, courier or other physical means will not be accepted.

### **SELECTION**

The Festival direction reserves the right to invite certain films to the selection by their own initiative, and will decide, according to its unquestionable judgment, on the admission of the films submitted for the Competition and will appoint a jury that will award the prizes.

When the author or production accepts the official invitation of the Festival, they undertake not to withdraw the film from the Festival program.

Authors of the films selected will have to submit, in the correct way and within the deadline established by the Festival's organization, the screening copy of the film (the screening format is DCP) and the one which will be eventually put online. Any other screening format will have to be discussed with the Festival direction, program office and the print traffic manager. Authors must also provide a digital screener of the final version of the film, with the same image (length, aspect ratio and frame rate) and sound (except for stereo mix) intended for the copy destined for screening; the dialogue list, both in the original language and in English (for non-Italian speaking films), high-definition stills of the film and the director, the press-book or presentation of the film and the promotional trailer. Authors of the films selected by the Prospettive Competition must also provide a copy for the official screening with Italian subtitles whether the spoken language is different from Italian.

Dates, venues, schedule and screening arrangements can be changed by the Festival direction without prior notice, but they will be promptly notified to the persons concerned.

It is the organizer's intention to do whatever it is possible to ensure that the screenings will take place in a theater. But in the event of administrative dispositions concerning public health partially or entirely precluding access to theaters, the direction will ensure to find on-line platforms, with limited access and restrictions on the number and location of those who can access, to allow the correct running of the event.

The author of the film or its producer are responsible for the contents of the submitted works and declare of having fulfilled copyright requirements and grant the explicit authorization for their use.

## **SHIPMENT AND INSURANCE**

Shipping (both inbound and outbound) and insurance costs, including those related to the screening copy, are at the expense of the participants, unless specific indications have been previously agreed with the direction of Filmmaker.

The Festival is committed to using the information on the entry forms in compliance with the provisions of the Articles 13 and 14 of the GDPR 2016/679 (General Data Protection Regulation).

The Festival declines any responsibility in case of wrong or missed reception of the submission forms, due to the transmission with any means or for any reason.

In case of extreme necessity, the organizers reserve the right to halt, suppress, delay the event, or to alter this regulation in accordance with the needs of its own operation. No damage will be acknowledged to the participants by reason of the aforementioned possibilities.

In case of controversies, the competent jurisdiction belongs to the Court of Milan.

The submission and participation of the films in the event implies the unconditional acceptance of the present regulation. In the event of unspecified cases and situations, any decision rests with the direction of Filmmaker.
